SECTION 4 : FIRST AID MEASURES

As a general rule, in case of doubt or if symptoms persist, always call a doctor.

4.1. Description of first aid measures

In the event of splashes or contact with eyes :

Wash thoroughly with fresh, clean water for 15 minutes holding the eyelids open.
Remove contact lenses.

In the event of splashes or contact with skin :

Watch out for any remaining product between skin and clothing, watches, shoes, etc. In the event of an allergic reaction, seek medical attention.
If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.
Remove at once any soiled garment. Wash at once and abundantly in water during at least 15 minutes.

In the event of swallowing :

Do not give the patient anything orally.
In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor.
Keep the person exposed at rest. Do not force vomiting.
Seek medical attention immediately, showing the label.
If swallowed accidentally, call a doctor to ascertain whether observation and hospital care will be necessary. Show the label.

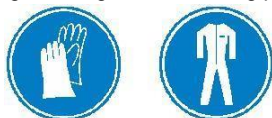
